Your complainant, having been first duly sworn, on oath, states that:

**Count 1: STRANGULATION AND SUFFOCATION, DOMESTIC ABUSE**

The above-named defendant on or about Sunday, April 24, 2022, in the Town of Marshfield, Wood County, Wisconsin, did intentionally impede the normal breathing by applying pressure on the throat or neck of another person, contrary to sec. 940.235(1), 939.50(3)(h), 968.075(1)(a) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And further, invoking the provisions of sec. 968.075(1)(a) Wis. Stats., because this charge is an act of domestic abuse, costs upon conviction would include the domestic abuse assessment imposed under sec. 973.055(1) Wis. Stats.

**Count 2: MISDEMEANOR BATTERY, DOMESTIC ABUSE**

The above-named defendant on or about Sunday, April 24, 2022, in the Town of Marshfield, Wood County, Wisconsin, did cause bodily harm to C.A.H., by an act done with intent to cause bodily harm to that person, without that person's consent, contrary to sec. 940.19(1), 939.51(3)(a), 968.075(1)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

And further, invoking the provisions of sec. 968.075(1)(a) Wis. Stats., because this charge is an act of domestic abuse, costs upon conviction would include the domestic abuse assessment imposed under sec. 973.055(1) Wis. Stats.

### **Count 3: MISDEMEANOR BATTERY, DOMESTIC ABUSE**

The above-named defendant on or about Sunday, October 23, 2022, in the Town of Dexter, Wood County, Wisconsin, did cause bodily harm to C.A.H., by an act done with intent to cause bodily harm to that person, without that person's consent, contrary to sec. 940.19(1), 939.51(3)(a), 968.075(1)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

And further, invoking the provisions of sec. 968.075(1)(a) Wis. Stats., because this charge is an act of domestic abuse, costs upon conviction would include the domestic abuse assessment imposed under sec. 973.055(1) Wis. Stats.

### **Count 4: MISUSE OF GPS DEVICE - OBTAIN INFORMATION**

The above-named defendant on or about Sunday, October 23, 2022, in the Town of Dexter, Wood County, Wisconsin, did intentionally obtain information regarding another person's movement or location generated by a global positioning device or a device equipped with global positioning technology that has been placed without that person's consent, contrary to sec. 940.315(1)(b), 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

### **Count 5: DISORDERLY CONDUCT, DOMESTIC ABUSE**

The above-named defendant on or about Sunday, October 23, 2022, in the Town of Dexter, Wood County, Wisconsin, while in a public place, did engage in violent, indecent, or otherwise disorderly conduct, under circumstances in which such conduct tended to cause a disturbance, contrary to sec. 947.01(1), 939.51(3)(b), 968.075(1)(a) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

And further, invoking the provisions of sec. 968.075(1)(a) Wis. Stats., because this charge is an act of domestic abuse, costs upon conviction would include the domestic abuse assessment imposed under sec. 973.055(1) Wis. Stats.

### **Count 6: DISORDERLY CONDUCT**

The above-named defendant on or about Sunday, October 23, 2022, in the Town of Dexter, Wood County, Wisconsin, while in a public place, did engage in violent, indecent, or otherwise disorderly conduct, under circumstances in which such conduct tended to cause a disturbance, contrary to sec. 947.01(1), 939.51(3)(b) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

Your complainant is a deputy with the Wood County Sheriff's Department and his information is based upon the records and files of the Wood County Sheriff's Department. Your complainant has relied upon those records and files in the past and has found them to be both truthful and reliable. According to those records and files:

1. Deputy Kirkeng of the Wood County Sheriff's Department reports that on October 23, 2022 at approximately 6:59 p.m., he was dispatched to a potential disturbance near Dexter County Park. The reporter indicated that somewhere near the north end entrance the caller could hear a male and female arguing with small children around. The caller also described a black suburban and silver Honda in the area.
2. Deputy Kirkeng reports that he located a Honda Pilot parked in a grassy area with a female outside of it near Townhall Road in the Town of Dexter, Wood County, Wisconsin. He reports that the female was identified as C.H., who stated that she and a friend were just attacked by her husband, Shyanne Harn, the defendant. C.H. stated that she drove from their residence on Klondike Drive to where they were currently on Townhall Road to meet up with a friend. C.H. stated that shortly after she arrived, the defendant also arrived at that location, and attacked her and her friend. C.H. stated that when the defendant arrived, he grabbed the other male, who was later identified as A.S., and the defendant was punching and hitting A.S. until he was able to get free and run from the area.
3. Deputy Kirkeng reports that C.H. stated that once A.S. got away, the defendant pushed her several times, pushed her to the ground, and kicked her repeatedly in the lower back area. He reports that C.H. had a scratch on the side of her neck. C.H. stated that the defendant also dragged her across the ground. C.H. indicated that she was currently in pain and that her lower back hurt. He reports that he also made contact with A.S., who stated that he was at the park fishing when C.H. came down to meet him. A.S. stated that the defendant arrived, shined a spotlight at him, got out of the car, and approached them. A.S. stated that the defendant grabbed him and took him to the ground. A.S. stated that he was eventually able to free himself from what he described as a "triangle choke hold," which caused him discomfort and he was able to get away. He reports that later an officer observed that A.S. appeared to have a bruise forming above his right eye.
4. Deputy Kirkeng reports that while on scene with C.H., she spoke about another incident that occurred between herself and the defendant on April 24, 2022. C.H. stated that the defendant came home to their residence on Klondike Drive in the City of Marshfield, Wood County, Wisconsin highly intoxicated and wanted to have sexual intercourse with her. C.H. stated that when she refused, the defendant became aggressive and struck her on the face, giving her a fat lip and causing her to bleed. C.H. stated that this caused her pain and she did not consent to being struck. C.H. stated that the defendant also put his hands around her throat and began choking her. She stated that she feared she was going to pass out because due to the lack of oxygen.

5. Deputy Kirkeng reports that he and another deputy went to the residence on Klondike Drive to speak with the defendant. He reports that the defendant stated that he was on his way back from Green Bay earlier in the day and was suspicious of C.H.'s behavior. The defendant admitted that at some point he bought an old phone from a friend and added the phone to his phone plan before putting it in the back of the Honda Pilot. The defendant stated that his intention in doing so was that he had a suspicious feeling that something was going on with C.H. and he wanted to see where she was going. The defendant stated that on this date when C.H. left the residence, he checked the location to see where she was going and when he saw where she stopped he got the kids into the vehicle and went to her location. The defendant stated that when he arrived, he saw C.H. and A.S. sitting on a blanket. When he made contact with them, they physically jumped him and were the aggressors.

6. Deputy Kirkeng reports that he also spoke with the defendant about the incident on April 24, 2022. The defendant admitted that he did come home intoxicated that night and knows C.H. claims that she had a fat lip. The defendant stated that he is not a physical person, he does not like to fight, and he would not put his hands on his wife.
